NOTES:

- The above results were reviewed by the Audit Committee at its meeting held on 10 August 2019 and thereafter approved by the Board of Directors at its meeting held on the same day. The Statutory Auditors have carried out a "Limited Review" of financial results for the quarter ended 30 June, 2019.
- 2. The Company has complied with the Ind AS 116 during the quarter in respect of the leasehold land taken from VPT. This change in accounting of lease rentals has resulted in reducing the total comprehensive income for the quarter by Rs.9.02 lakhs.
- 3. The Company is in Inorganic Chemical Business segment.
- 4. Silicic Acid supply from adjacent Fertilizer Complex continues to be a problem. However, to meet the commitments of customers, efforts are being made to procure Silicic Acid though expensive from other sources.
- 5. Segmental reporting as per Ind AS-108 issued by the ICAI is not applicable, as the Company is engaged in manufacture of a single line of product.
- 6. Figures for the previous period have been regrouped, wherever necessary, to conform to the current period's classification.
- 7. Pending investor's complaints for the quarter ended 30th June, 2019 NIL.
